"Call for the entire by records leading upto G.O.Rt.No.82, dt.23.02.2016 and G.O.Rt.No.44, dt.25.01.2016 issued by the 1st respondent, declare the same as illegal, and set aside the same and further direct the respondents to continue the petitioners as staff nurses in the 2nd respondent hospital (GGH) and further appoint them on contract basis".

The Hon'ble High Court passed the following interim orders on 08.03.2016

"There shall be status quo as on today with record to the petitioner only".

The W.P still pending before the Hon'ble High Court. Out of 63 petitioners 57 were absorbed as staff nurses on contract basis in various subsequent recruitments and are working in APVP/DM&HO/GGH.

In respect of the remaining 6 candidates age barred candidates-03 (they were removed on 31.05.2023), expired-01, Not accommodated -02 (as they were not selected in any subsequent recruitments).

It is also submitted that, consent letters have been obtained from all the 57 writ petitioners who were absorbed as staff nurses where in they stated that they have no objection to fill the vacancies and they are also going to withdraw the writ petition filed by them. (Out of 57, 40 candidates were already given the consent letters).
