- > Age relaxation for OBC / SC / ST / PWD / Ex-Servicemen will be as per rule.
- > The post is purely on ad-hoc basis for a period of 39 days extendable by another 39 days Subject to Satisfactory Performance.
- The appointment will be subject to his/her being declared medically fit and satisfactory verification of his/her character and antecedents.
- No other benefit will be extended to him/her as admissible to regular ESIC employees. He/ She will have no claim whatsoever for regularization for their services in this hospital.
- Private practice of any kind will not be allowed.
- No TA/ DA will be admissible either for appearing for Interview, for medical examination or for joining the post.
- Submission of declaration of marital status and declaration of having only one living spouse in case of married individual and making solemn affirmation to the effect of registration of marriage and taking an oath of allegiance/ faithfulness to the Constitution of India.
- ➤ It is a contractual post for 39 days only and contract will be signed on a stamp paper of Rs.100/- The original contract will be with the hospital and its copy will be with candidate.
- > He/ She will be entitled to avail off leave days which will be computed at prorate basis of 2 (Two) days in tenure of 39 days of services rendered by him/her. No half day is allowed.
- 1. He/ She will not be entitled to avail any other kind of leave.
- 2. He/ She will not be entitled to Medical and other kind of benefit.
- 3. The duties of the Senior Resident will be as assigned by Medical Superintendent of the hospital. They will be required to attend emergency duties as assigned by M.S. or HOD or other senior medical officers.
- 4. While on emergency duty the Senior Resident will not leave the department without handing over the charge to the reliever.
- 5. The Candidate Will be required to deposit a security of **Rs.3000/** through Demand Draft in favour of **ESI Fund Account No.1** payable at **Mumbai** at the time of joining which is refundable after completion of tenure period and production of "No due Certificate".
- 6. The services can be terminated at any time without serving any notice/assigning any reason. However, the engagement shall automatically come to an end on the expiry of their period herein first mentioned and no further notice would be required for termination of contract of the first party.

- 7. No experience certificate will be issued unless the full term is completed.
- 8. If he/she does not complete the period of 39 days, he/ she will not claim any dues in r/o salary.
- 9. No hostel accommodation/ quarters will be provided.
- 10. No conveyance/ Ambulance will be provided to attend emergency calls.
- 11. Absence from work for a period of continuous five days will amount to voluntary abandonment of engagement and no further order of disengagement shall be necessary.
- 12. If any time he/she found guilty of any misconduct with ESIC Beneficiaries, Staff, Officials of negligence of him/her duties then the Medical Superintendent of the hospital may terminate his/her contractual engagement with immediate effect and likely forfeiture of security money and experience certificate may not be issued and no amount will be paid to him/her in lieu of any notice.
- 13. He/ She is required to produce original documents along with photocopies of substantiating him/ her age matriculation certificate educational qualification, experience and MMC / MCI Registration certificate.
- 14. If any declaration given or information furnished proves to be false or if the candidate is found to have willfully suppressed any material/information, he/she will be liable to be removed from services or such other action as deemed fit will be taken by the appointing authority.
- 15. Selected candidates will have to sign Agreement of Terms & Conditions on Rs. 100/- Stamp paper to be purchased by the candidate prior to joining.
- 16. Any Senior Resident participates in strike or demonstration pay will be deducted accordingly & necessary disciplinary action as deemed fit will be taken against the doctor.
- 17. The cutoff date with respect to qualification for all posts is **01.07.2023**.
- 18. The decision of the selection board will be final on all aspects of selection and no further correspondence will be entertained under any circumstance.
